CIRCULAR

Subject: School Scholarship Scheme (SSS) for the students of Grade VI-XII and SCC

Dear Parents,

In view of the current pandemic and financial hardships being faced by the parents, school is inviting the applications from the eligible parent to avail the fee concession.

Criteria for Application. Following criteria shall be applied for the consideration of SSS to a child: -

- a. The scheme is applicable to Indian citizens only.
- b. It is not an open scholarship. It is expected that only needy parents should apply for consideration. Parents should have applied for the grant of SSS on the designated form and fulfilled the economic criteria and verifications.
- c. Of the applicants, parents receiving the lowest aggregate salary (together for the father and mother), will be considered as the benchmark and applications will be accordingly incrementally considered. In no case the difference of aggregate salary between the applicants should exceed SR 500.
- d. SSS will be considered for student numbers not exceeding 2% in a specific class.
- e. SSS will be extended separately to boys and girls sections.
- f. Applicant child should have been studying in the IIS for at least two years before seeking first consideration. Cases not considered during the first year may be reconsidered for the next year.
- g. The consideration will be held once in the academic year unless reviewed.
- h. The scheme shall not apply to students of Class 5 and below.
- i. SSS will be applied to only one child from a family. No two siblings will be considered for the grant of the SSS.
- j. SSS will be granted for a maximum of two successive years and reviewed thereafter. There has to a period of two years before the parent can reapply for consideration under the scheme.



k. The only consideration for grant of SSS will be the economic conditions of the parents and no other criteria such as academic performance, sports achievements, extracurricular activities or miscellaneous aspects will be applied for considerations.

l. Parents are required to furnish written documents for their collective proof of income (husband and wife), duly attested from their employers and General Organization for Social Insurance certificate reflecting their salary. In the absence of either of the two the application will not be considered.

m. Based on final approvals the SSS will be granted at the scale of 50% of the aggregate monthly fee.

The interested eligible parents can apply for the scheme by filling up the prescribed application form enclosed with this circular and email the application with relevant documents at **principal@iipsr.edu.sa** latest by **14:00 Hrs. Thursday, 27 October 2022.**
